



## 2021 FEE SCHEDULE

### Application and Establishment Fees

Applications for enrolment must be made on the College's application form and accompanied by payment of a \$55 fee. This fee is non-refundable.

Acceptance of offer of enrolment must be made in writing and accompanied by payment of a \$1,500 Establishment Fee.

### School Fees

School Fees are due before the start of each term. School Fees paid annually by 31 January 2021 will receive a 2.0% discount on the Total Fee.

Camps, charter bus charges and non-compulsory activities will be billed each term.

**Fee Reduction:** Families with four or more children attending the College receive a 75% fee reduction for the fourth and subsequent children.

**Late Payment:** An administration charge of \$55 per term applies for late payment.

### Camps, Sports & Excursions Fund (CSEF):

Parents of eligible students who hold a valid means tested concession card or temporary foster parents are eligible to apply. Payments will go directly to the school and be allocated to the student's fees account. # FEE PAYMENT OPTIONS - 2021

The following options are available for payment of 2021 fee accounts:

## a) Annual Payment

Pay by 31 January 2021 and receive a 2.0% discount on the Total Fee. Late applications will not be accepted.

The annual payment is for fees and all compulsory activities including excursions, diaries, yearbook and other levies. All camp fees, charter bus charges, and other non-compulsory activities are still payable on a term basis, due on the dates detailed below.

## b) Term Payment

Term fees are due and payable before the start of each term.

For 2021 the due dates are:

Term 1	Friday, 29 January 2021
Term 2	Friday, 16 April 2021
Term 3	Friday, 9 July 2021
Term 4	Friday, 1 October 2021

Note: Year 12 fees are charged over Terms one to three.

## c) Instalment Method

Any other payment methods must be arranged with the approval of the Finance Manager. Note: Instalment arrangements do not roll over from previous years.

## GENERAL NOTES

Statements will be issued four times a year, and will be payable before the start of each term. Term 1 accounts will be issued in mid January. Statements for Terms 2, 3 and 4 will be issued during the last week of the preceding term.
